5. It is mandatory to develop a website of medical college/institution and display all the information of college and courses offered as per the guidelines issued by National Medical Commission (NMC) from time to time.

**6. This LOP is subject to confirmation of Bank Guarantee. If any discrepancy is found lateron in respect of any data/documents, the LOP shall be withdrawn immediately.**
